Creating a smokefree generation and tackling youth vaping consultation: government response

VAPING CONSULTATION: GOVERNMENT RESPONSE"

Department of Health and Social Care, - 29th January 2024

The large majority of responses supported the government proposal to create a smokefree generation.

Respondents were mostly in favour of the proposed measures to tackle youth vaping, particularly restricting point of sale displays and restricting packaging. Although there were mixed views on how best to do this. There was also support for extending these regulations to cover non-nicotine vapes as well as to other consumer nicotine products, such as nicotine pouches, to avoid loopholes and support stronger enforcement.

Respondents were strongly in favour of introducing a ban on the sale and supply of disposable vaping products.

There was significant support for enforcement across the tobacco and vaping measures including introducing new fixed penalty notices in England.

The UK Government and devolved administrations will now bring forward measures to create the first smokefree generation and tackle the rise in youth vaping.

The UK Health Security Agency (UKHSA) is responsible for protecting public health in the UK, supporting global efforts to improve public health and has been world-leading at implementing pathogen genomics services to do this.

The UKHSA Pathogen Genomics Strategy will:

- target international, national and regional public health priorities
- develop accredited, resilient genomic services for target priority pathogens
- communicate information that leads to improved clinical care and outcomes for individual patients
- provide demonstrable public health benefit
- deliver a cost-effective service, to provide value for money
- share infrastructure and expertise throughout and beyond the organisation

This strategy sets out how we will implement a programmatic approach to pathogen genomics in the future. This includes governance and oversight mechanisms for reporting the impact of this work upwards and outwards, staff training and retention, cross-team working, and accountability to ensure the benefit to public health is maximised.

Increasingly, GP practices are no longer offering ear wax removal services. This report analyses Freedom of Information requests sent to all 42 integrated care boards (ICBs), the commissioners of most NHS services, in England. Results show that less than half of ICBs are commissioning ear wax removal services in line with NICE guidelines. Findings also show that most ICBs commission some services but people can only access them if they live in certain parts of the ICB area, and at least seven ICBs commission no ear wax removal services at all.

People living with severe mental illness face a 15 to 20 year shorter life expectancy than the general population. This is largely due to physical illnesses that could be prevented or treated.

One of the ways to tackle this unacceptable inequality is by ensuring everyone with severe mental illness is supported to access an annual physical health (PHSMI) check. This report with Equally Well UK, commissioned by NHS England, explores how new investment has been used around the country to improve outreach services and increase uptake of the PHSMI check.

Reaching out illustrates the barriers that can prevent people from accessing their physical health check, such as finding morning appointments challenging due to drowsiness from medication, or distrust of NHS services due to previous experiences (including compulsory treatment). It highlights the importance of coproduction in designing outreach initiatives to remove these barriers.

It also contains a handy information sheet with key tips on widening access to physical health checks for people with severe mental illness, such as using point-of-care testing kits to take PHSMI checks to where people are, or supporting people with travel to the GP surgery.

The report calls for outreach to be part of a wider strategy to improve the physical health of people living with severe mental illness and reduce the mortality gap.

Food insecurity levels in the UK have reached unprecedented highs over the past few years, first in the face of the Covid-19 pandemic and now continuing through the cost of living crisis.

Disabled people have been particularly exposed to food insecurity, facing stark inequalities when it comes to accessing and affording the food that they need. A quarter of the population, equating to 16 million people in the UK, including one in 10 children, are disabled – a proportion which has doubled in the last decade.

While improving access to food for disabled people requires a holistic, individualised approach, there are a numerous commonalities disabled people experience that policymakers must address to reduce food insecurity.

More than 7,000 Covid-related hospital admissions could have been prevented in the UK in the summer of 2022 if the population had received the full number of jabs recommended, according to research in The Lancet.

Some 44% of the UK population was under-vaccinated, with younger people among the most likely to skip doses.

In a first, health records for everyone over five in the UK were analysed. The same approach could now be used to understand other diseases.

The entire population of the UK is 67 million, and all those over the age of five had their anonymised electronic health data analysed for The Lancet study.

It found that between June and September 2022, the percentage of people not fully vaccinated against Covid was:

- 49.8% in Northern Ireland
- 45.7% in England
- 34% in Scotland
- 32.8% Wales

A new study published in the Public Health journal adds further worrying evidence that consumption of energy drinks high in caffeine and sugar can be harmful to the health of children and young people. In the comprehensive study researchers from Fuse, the Centre for Translational Research in Public Health at Teesside University and Newcastle University, looked at data from 57 studies of over 1.2 million children and young people from more than 21 countries.

Additional health effects noted in the research review include increased risk of suicidal thoughts, psychological distress, attention deficit hyperactivity disorder (ADHD) symptoms, depressive and panic behaviours, allergic diseases, insulin resistance, and tooth decay. The study also links consumption of the drinks with an increased risk of poor academic performance, sleep problems and less healthy dietary patterns. Energy drinks consumption has also been associated with increased risky behaviours such as substance abuse, violence and unsafe sex.
