RCEM - January 2024

The Royal College of Emergency Medicine (RCEM) has <u>updated its guidance for Emergency</u>

<u>Department (ED) crowding</u> in response to the increasing threat to timely emergency care and the impact it is having on Emergency Medicine clinicians and their patients.

Initially issued in 2015, the 2024 update to the guidance supports further understanding of the causes and effects of crowding and provides more options for health systems.

How to improve investigations of medical harm

NIHR – 10th January 2024

Investigations into life-changing medical harm (including injury or death) aim to establish what happened, learn lessons, and bring justice to the people affected. Research found that those who have experienced harm want reviews to be transparent, trustworthy, and person-centred to meet their needs. People want to be meaningfully involved in the process and to be treated with respect and empathy.

Researchers from the University of Exeter analysed 41 studies exploring the views of people who had gone through an investigation of a life-changing event.

The findings could help the NHS conduct reviews that feel and look fair to people who have experienced medical harm. They could help people understand what to expect from a fair process.

Positive Voices is a nationally representative survey of patients attending HIV specialist care in England, Wales and Scotland. The survey includes patient-reported data on: HIV knowledge, diagnoses and treatment; health conditions and medication; health care use and satisfaction with HIV specialist services and GP services; health-related quality of life and wellbeing; general health and health-related behaviours; stigma and discrimination; housing, employment and finances; met and unmet health and social care needs; and the impact of Covid-19.

Patient Perspective – 2023

The data collected from the national patient surveys can seem overwhelming, and even when the results are made clear, and trusts have an opportunity to identify strengths and areas for improvement, it can be hard to work out how

to go about making changes in response to the feedback patients have given. Patient Perspective is an approved contractor for the National Patient Survey Programme and has been working with trusts for nearly 20 years. As part of our service, we have developed case studies of good practice. Case studies are based on the projects, initiatives and service improvements trusts have undertaken to bring about change.

The case studies aim to highlight and share examples of service improvements made due to several factors including poor scores, issues and themes highlighted by patients from the national surveys and often linked to feedback from patients from other methods of patient involvement.

In this report we will draw from up-to-date evidence and our previous acute insight series reports to examine the issue of burnout in the EC workforce and how addressing this core problem is key to maintaining both standards of practice and workforce retention. The capacity of our emergency healthcare workforce is currently compromised beyond what is safe. To deliver adequate care consistently, within the context of high demand, whilst beyond capacity and on an unrelenting basis, is simply unrealistic and can only result in poor outcomes for patients and staff alike. Action is needed to address these issues urgently.

This document issues an updated recommendation on the assessment of PPH and a new recommendation on the use of a treatment bundle for the management of PPH.

The National Cancer Audit Collaborating Centre (NATCAN) has published a State of the Nation report from the National Oesophago-Gastric Cancer Audit (NOGCA) on the care received by people with oesophago-gastric cancer in England and Wales from 1 April 2020 to 31 March 2022.

OG cancer predominantly affects older people and occurs more frequently in men than in women, though there is variation by tumour type. Stomach cancer as a proportion of all OG cancers continues to decline, accounting for 25.1% of all cases diagnosed in 2021/22 compared to 33.8% in 2012/13. Over two-fifths of people in the audit were diagnosed with stage 4 (metastatic) disease, an increase from 37% in 2012/13.

The National Cancer Audit Collaborating Centre (NATCAN) has published a State of the Nation report from the National Prostate Cancer Audit (NPCA) on the care received by people with prostate cancer in England and Wales from 1 January 2019 to 31 January 2023. Key messages include:

The proportion of men diagnosed with high-risk/locally advanced prostate cancer undergoing radical prostate cancer treatment remained stable when comparing to 2019

The proportion of men diagnosed with low-risk localised prostate cancer undergoing radical prostate cancer treatment was 8% in England and 9% in Wales

There was an increase in men newly diagnosed with prostate cancer in 2022 in England, and in 2021 in Wales

There was an increase in men newly diagnosed with prostate cancer treated with either radical prostatectomy or radiotherapy in 2022 in England

The proportion of patients experiencing a genitourinary or gastrointestinal complication within two years of radical treatment remained stable in England and Wales, when comparing to 2015-2019

There were changes in some aspects of prostate cancer treatment, including an increased utilisation of ultra-hypofractionated radiotherapy and a shift in the systemic agents used.

Sherwood Forest Hospitals NHS Foundation Trust was keen to introduce the Royal College of Nursing's Rest, rehydrate and refuel initiative, and did so through a project led by one of the chief nurse clinical fellows. First, staff were surveyed to understand the current situation and any barriers they may face. This was followed by a trial on two pilot wards, before roll-out of a trust-wide campaign.

Institute of Health Equity (IHE) - January 2024

This report confirms that a million people in 90% of areas in England lived shorter lives than they should between 2011 and the start of the pandemic. Using several published Office for National Statistics data sources, the IHE made these calculations from the number of excess deaths (the increase in the number of deaths beyond what would be expected) in the decade from 2011 in England.
